## CAUTION

**COMPOSITION:** Albendazole 1,9 % m/v,  
Closantel 3,0 % m/v

Store in a cool place and protect from direct sunlight.

### WARNINGS

- NOT FOR USE IN MILK GOATS WHOSE MILK IS INTENDED FOR HUMAN CONSUMPTION.**
- Allow 30 days between last dosing and slaughter for human consumption.
- Management practices should always ensure that all drenching procedures are carefully carried out.
- It is particularly important not to exceed the recommended dose in ewes during the mating season, or during the first month of pregnancy.
- Although this remedy has been extensively tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.
- Keep out of reach of children, uninformed persons and animals.

### PRECAUTIONS

- It is recommended that all sheep be vaccinated against Pulpy Kidney disease before dosing with any worm remedy.
- Do not treat animals more frequently than every three weeks.
- Wash hands thoroughly after use.
- Handle with care.

### DIRECTIONS FOR USE: USE ONLY AS DIRECTED.

Use as an oral drench. Shake well before use.

- Moet nie diere vir menslike verbruik binne 30 dae na behandeling slag nie.
- Volg bestuurspraktyke wat sal verseker dat dosering versigtig uitgevoer word.
- Dit is veral belangrik om nie die dosis te oorskry in ooie gedurende paartyd en die eerste maand van dragtigheid nie.
- Alhoewel hierdie middel breedvoerig onder 'n wye verskeidenheid van toestande getoets is, mag dit faal as gevolg van verskeie redes. Indien dit vermoed word, raadpleeg 'n veearts en verwittig die registrasiehouer.
- Hou buite bereik van kinders, oningeligte persone en diere.

### VOORSORGMAATREËLS

- Dit word aanbeveel dat alle skape teen Bloednier siekte ingeënt word voordat dosering met enige wurmmiddel plaasvind.
- Moet nie diere meer dikwels as elke drie weke behandel nie.
- Was hande deeglik na gebruik.
- Hanteer versigtig.
